- The footnotes should be in Times New Roman, font size 10 with spacing of 1.0
- One-inch margins should be maintained on all four sides
- · Citation Style: Latest Bluebook (20th Edition)/APA style of citation
- The maximum length of the paper shall not exceed 3500 words, (excluding foot notes/end notes/annexure/reports etc.)
- · All abstract/full paper submissions are to be made in Microsoft Word (.doc).


