Anti-Ragging Committee

Definition of ragging:

Acts that constitute ragging in universities include physical abuse such as hitting, slapping, or kicking students; verbal abuse such as shouting, insulting, or using derogatory language; forced actions like performing humiliating tasks or acts against one's will; psychological harassment such as intimidation, threats, or spreading rumours; and any behaviour that creates a hostile or intimidating environment for students, causing them distress or harm. Ragging also encompasses actions that violate the dignity and rights of individuals, leading to a negative impact on their well-being and academic experience.

Objectives of the committee:

- To formulate strategies to prevent and discourage menace of Ragging on and off the campus.
- To examine the complaints lodged by the students on any kind of Ragging and to conduct an enquiry in this regard.
- To organize awareness Programmes on gender equity, human rights and dignity, moral and ethical values

Functions of the committee:

- **Guidelines formulation**: The committee is responsible for formulating guidelines related to anti-ragging measures which includes the complaint handling protocols and consequences for individuals who engage in it.
- **Complaint redressal**: The committee is responsible in creating an environment to communicate without hesitation. The committee receives and investigates ragging-related complaints. They ensure that complaints are handled in a timely, discreet, and unbiased manner, safeguarding the rights of the complainant and the accused. The cases can be escalated to higher authority in the university in case if it is not solvable by the committee.
- **Counselling and support**: The committee ensures the well-being of ragging victims and assists them in reintegrating into college life by offering counselling and other services. To address underlying problems and stop recurrences, they might also provide counselling and rehabilitation programs with the help of counselling centre and include committee like Hostel Disciplinary committee for required support.
- **Monitoring and Reporting**: To identify any possible instances of ragging, the committee keeps a close eye on the campus environment.
- **Awareness programs**: To inform students, instructors, and staff about the negative effects of ragging and the significance of upholding a courteous and welcoming campus community, they host awareness workshops.

Meeting:

- The committee shall meet at least **two times** a year and as per the cases raised.
- The member Secretary, in consultation with the Chairman of the Committee, shall prepare a provisional agenda for meeting. It shall be circulated to all Members of the Committee two days before meeting. All the decisions should be taken based on majority. After the meeting, the Committee shall approve a report embodying its views, recommendations, and decisions. The MoM should be shared with the concerned University Offices with a copy marked to IQAC.
