Hostel Disciplinary Committee

The Hostel Disciplinary Committee of REVA University plays a crucial role in maintaining a conducive and respectful living environment within the hostels. By upholding standards of conduct and fairness, the committee contributes to the overall well-being and safety of hostel residents, fostering a positive community atmosphere conducive to academic success and personal development.

Functions:

- Maintaining Order: Ensure discipline and order within the hostel premises.
- Enforcing Regulations: Enforce hostel rules and regulations set by REVA University.
- Addressing Complaints: Address and investigate complaints related to misconduct or rule violations within the hostel.
- Promoting Safety: Promote a safe and secure living environment for all hostel residents.
- Educational Initiatives: Organize educational programs and workshops to promote awareness of hostel rules and values.

Rules and Procedures:

- All complaints regarding hostel misconduct or rule violations should be submitted in writing to the Committee. Complaints will be investigated promptly and confidentially.
- The committee will conduct fair and thorough investigations, which may involve interviewing witnesses and gathering evidence. The accused individual(s) will be given an opportunity to present their side of the story.
- After investigation, the committee will deliberate and decide on appropriate disciplinary actions based on the severity of the offense and any prior incidents. Decisions will be made by consensus or majority vote among members.
- Disciplinary actions may include warnings, fines, community service, or more severe measures like suspension from hostel facilities. Repeat offenders or serious violations may be referred to higher university authorities for further action.
- Individuals subjected to disciplinary actions have the right to appeal to the university's higher authorities within a specified timeframe.
- Committee decisions and outcomes will be communicated transparently to all relevant parties while respecting confidentiality.

Meeting Frequency and Reporting:

The committee shall convene regular meetings (quarterly or as and when required) to ensure discipline and order and address any emerging issues. Minutes of meetings and activity reports should be documented and shared with relevant stakeholders and IQAC.
